## Summer Housing 2019

### Availability and Eligibility

Welcome to summer housing at West Virginia University Potomac State College! The Office of Housing & Residence Life makes available a residence hall (University Place) for summer housing. Summer housing is provided for students affiliated within West Virginia University Potomac State College. **Students are permitted to reside in the residence hall while classes are in session.**

### Summer Housing Dates

Sunday, May 12 – Check-in for sessions beginning May 13  
Monday, May 27 – Memorial Day recess (no services available)  
Thursday, July 4 - Independence Day recess (no services available)  
Friday, August 2 – **vacate residence hall by 12 p.m.**

### Rates

Cost per each session is based on the current daily rate. (The cost per session is approximately \$882 (4ppl/1 bath) and \$1008 (2ppl/ 1 bath) per 6 week session) Note: This rate is for the room only and is subject to change without notice. If your class is not held for a full session, you will be charged a pro-rated amount based on the number of days registered for classes. There are no refunds for partial weeks. Refunds will only be made in the event of withdrawal from West Virginia University Potomac State College. Participation in meal plan services is optional during summer sessions. The plan offered includes any 80 meals at a cost of \$592. This rate is subject to change without notice. Once all meals are depleted an additional meal plan may be purchased. Refunds are not issued for unused meals. For questions regarding the meal plan, please contact Dining Services at (304) 788-7211.

### Check-in and Check-out

Students arriving for summer should report to the Office of Housing & Residence Life in University Place between noon and 4 pm on the appropriate check in date, as shown above. The meal plan begins on the first day of classes.

The last day of your summer school class is also the last day of the summer school housing. Please make note of this and make arrangements to remove your belongings by 12 p.m.

### Cancellation of the Housing Contract

The last date to cancel the housing contract is the last weekday **BEFORE** your summer session is scheduled to begin.

### Accommodations and Meals

University Place offers suite style living arrangements. In addition, they are air- conditioned and have a vanity sink in each room. Wi-Fi and cable TV service is provided in the rooms.

Students must supply their own sheets (XL Twin), pillows, blankets, towels, toilet tissue, cleaning supplies, TV, and computer.

Students are responsible for the care and cleaning of the rooms. Housekeeping staff will clean toilet and shower area every two weeks. **Rooms must be returned to their original condition when vacated.** Any damages beyond normal wear and tear (as determined by the Office of Housing and Residence Life) will be charged to the student.

A dining plan is available through Dining Services. Participation is not mandatory and service is provided as a convenience only. For more details, call (304) 788-7211. **Meals are not available on weekends or during holiday recesses.** There are dine-in and fast food restaurants and convenience stores located within a short driving or walking distance of campus.

## **Supervision**

Housing & Residence Life staff will be available to assist students. Students are responsible for conducting themselves within the guidelines of West Virginia University Potomac State College policies (found in the Housing and Residence Life Handbook online at [http://www.potomacstatecollege.edu/campus\\_life/residence\\_life\\_housing/2017-2018-%20Housing-Residence-Life-Handbook.pdf](http://www.potomacstatecollege.edu/campus_life/residence_life_housing/2017-2018-%20Housing-Residence-Life-Handbook.pdf) ), as well as, all West Virginia State and Federal laws and regulations.
